2. **Experience:** Candidate should have completed total 3 years of teaching and/or research experience at a recognized institution, after obtaining the post graduate qualifying degree of Assistant Professor, as on the date of interview **OR** 1 year of teaching and/or research experience, after obtaining the degree of DM (2-year duration) in the concerned specialty. No further experience is needed for the candidate holding the degree of DM of 3 years duration in the respective departments.
3. **Upper age limit:** 50 years for Assistant Professor as on the date of interview. The age limit may be relax able, for government servants, and candidates belonging to scheduled castes / scheduled tribes / other backward class/ Ex-Serviceman as per U.P. Govt. rules.
4. **Service Term and conditions:-**

- a. This appointment is **purely on contractual basis** which may be terminated at any time without assigning any reason.
- b. The appointment will be for a period of one year with effect from the date of joining. If the contract is not extended further, the same will lapse automatically.
- c. The consolidated remuneration will be Rs. 1,01,500 per month.
- d. The appointee shall not be entitled to any other benefit such as provident fund, pension and gratuity, seniority, promotion, allowance, facilities etc. or any other benefits available to the Institute employees on regular basis.
- e. The appointee shall not be granted any claim or right for regular appointment to any post at SSPGPGTI, Noida.
- f. This appointee is full time and the appointee will not be allowed to engage himself/herself in any kind of other work of private practice of any kind.
- g. The appointee will have to perform the same duty as required by regular assistant professors of this institute including night duty and duty on holidays
- h. In addition to duties of assistant professor in the concerned department, you may be required to perform other duties as may be assigned to you from time to time by the competent authority of the institute. No extra/additional allowances will be admissible in case of such assignment.

Please bring a set of Copy of all academic records, experiences etc., including official certification of each degree earned from each institution of higher learning attended and official transcripts of each examination passed (if the record are not in English/ Hindi, a certified English/ Hindi translation must be provided)
